TERMS AND CONDITIONS

The bride and groom must sign a wedding video contract before services are rendered.

A \$ _____ non-refundable deposit is required to secure date. The deposit will be put towards your final bill.

If the wedding is cancelled or the date is changed, the initial deposit is forfeited. An additional \$100.00 non-refundable deposit will be required to secure a new wedding date.

KC Video accepts money orders, and personal checks. There is a \$35.00 fee for any returned checks. If the deposit is paid by check and the check is returned, the contract is void and the date is no longer secured.

It is the sole responsibility of the client to secure permission of the church, synagogue or other officials to film the ceremony. The deposit is non-refundable if such officials prevent filming. KC Video will abide by the rules of the church or synagogue regarding camera placement at the ceremony.

KC Video will take utmost care to produce a tape of good quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, equipment malfunction, and defective tape stock, videographer illness, fire or other casualty, or client misuse of equipment. If filming is prevented due to such occurrences, all money paid (less deposit) will be refunded.

KC Video reserves the right to terminate contract for any reason at any time. Should KC Video terminate contract, all monies paid will be refunded.

Under any and all circumstances, the total liability of KC Video is limited to the refund of the deposit.

All audio and video footage is the copyrighted property of KC Video. KC Video reserves the right to use any and/or all footage for promotional, publicizing, exhibition, and/or other exploitation thereof in any manner and by any means and in connection with commercial advertising and publicity tie-ups.

The video is strictly produced for the client's private, home use only. Any duplication or broadcast (including internet use) without written consent of KC Video is strictly prohibited.

Clients assume all liability for any form of copyright infringement.

It is the client's sole responsibility to inform KC Video of any specific needs or changes in events.

All DVD's will be DVD-R format, and will require a player capable of reading a DVD-R disk. Although DVD-R is the most compatible publicly available recording format to date, no guarantees can be made by KC Video that they will work on your player. DVD-R disks can be substituted with VHS tapes if compatibility is an issue. (3) Copies of edited wedding video will be included in package (DVD or VHS). Additional copies can be purchased for \$20 each. If they must be mailed, actual shipping charges will be paid by buyer.
